Distributions may consist of net income, dividends, and/or net realized capital gains and are taxable in the hands of the investor. Monthly distributions are based on record date on the second Thursday of the month, payable on the second Friday of the month. The final distribution in respect of each taxation year is paid or payable by December 15<sup>th</sup> of each year or at such other times as may be determined by the fund's manager. Distributions are automatically reinvested unless an investor elects to receive them in cash, except the ETF series where distributions are automatically paid in cash unless an investor elects to receive them in cash, except the ETF series where distributions paid may include a return of capital and an investor's original investment will decrease. A return of capital is not taxable to the investor, but will generally reduce the adjusted cost base of the units held for tax purposes. If the adjusted cost base falls below zero, investors will realize capital gains equal to the amount below zero.
